



Continuing Health Professions Education

Lincoln Medical Education Partnership provides Advanced Cardiac Life Support (ACLS) for Experienced Providers (ACLS-EP) for health care professionals according to the guidelines of the American Heart Association.

The ACLS-EP Course is designed to challenge physicians, nurses, physicians assistants and emergency medical personnel who routinely use their ACLS skills. An interactive format is used requiring a basic current understanding of ACLS algorithms and practice skill. Course emphasis is at an advanced level and minimal time is devoted to didactic material, ie, presentation.

You will be required to take and pass the ACLS written test along with successful demonstration of CPR Provider skills, use of an AED and mega code demonstration to complete this course.

You will be asked to read and review ACLS for Experienced Providers, which is provided to you in your pre-course packet. Be prepared to actively discuss the learning station cases. Please note that this course will be a group interactive discussion and you will be called on in each learning station to contribute. **THIS COURSE IS NOT LECTURE FORMAT.**

Participants are strongly encouraged to evaluate their knowledge and skill level prior to registering for ACLS-EP.

ACLS For Experienced Providers

Completion of the program is based on criteria established by the American Heart Association (AHA). Upon successful completion, an AHA card will be issued which verifies ACLS provider status for two years.

Prerequisite: All participants **must** have renewed their ACLS certification at least twice prior to registering for this course.
